PET BOARDING POLICIES & RELEASE OF LIABILITY Owner

***KITTY SLUMBER PARTY AND GROOMING CONTRACT AND DISCLAIMERS- FOR KITTY GROOMING/BOARDING YOU MUST ALSO DIGITALLY SIGN THE DOGGY DISCLAIMER AS WELL. WE APOLOGIZE FOR THIS INCONVENIENCE. AFTER DIGITALLY SIGNING YOU MUST CREATE BOTH PARENT AND PET PROFILES. ALL SERVICES ARE BOOKED FOR YOUR PET, NOT YOURSELF.***

Do not bring items with your cat(s) that are valuable or irreplaceable. I agree that BCP shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my cat or me. **COMMON FELINE MALADIES** – I am aware that vaccinating my pet only protects them from known strains of viruses. BCP. cannot control airborne viruses and allergens. If my pet becomes ill while boarding, the staff will contact me. If my pet becomes ill once returning home, I agree to let the pet resort know as soon as possible. **INFESTATION** – Pets entering this resort must be free of fleas and ticks. If your pet enters our resort with fleas or ticks you will be assessed an infestation fee at owner's expense.

**CAT PLAY ACKNOWLEDGMENT** - I hereby waive and release Beau's Chateau for Pets and its staff from any liability of any nature for any injury or damages which my cat may suffer, including specifically, but not limited to, any injury or damages resulting from the action of any cat and I expressly assume the risk of such damage or injury. I understand that I am liable for any medical expenses incurred by a staff member or damages that result from injuries caused by my cat. Furthermore, shall it be determined by us that injury to any other cat was the result of the aggressive behavior of my cat; I may be held liable by the owners of said injured cat. In consideration of this, I also understand and consent that my name and contact information may be provided to the owner of the injured cat to settle said expenses. By signing this agreement, I hereby agree to hold BCP and its staff harmless from any and all claims. I agree to: All the terms and conditions contained in this contract. I allow BCP. to transport my pet for veterinarian care. In an emergency, I agree that BCP, as my representative/agent may transport my cat to the closest veterinary clinic and I agree to assume all costs incurred. I release Beau's Chateau for Pets, its affiliates, staff, owners and managers from any liability that may arise directly or indirectly from any activity or service that I authorize for my pet while in the resort. **ABANDONMENT** - State statutes consider pets to be abandoned if not picked up by the owner(s) after 14 days (without any verbal or written contact with BCP) following the arranged pick up. Abandoned pets become the property of the pet resort. **EVENT OF CATOSTROPHIC HAPPENINGS:** BCP shall not be responsible for pet replacement over the cost of \$1,000/family. **RIGHT OF REFUSAL:** Beau's Chateau for Pets reserves the right to refuse admittance to any pet or dismiss any pet that does not meet our daycare/boarding standards. The determination shall be made at the sole discretion of Beau's Chateau for Pets. **PHOTO & VIDEO RELEASE** - I agree to allow BCP. to use my pet's name and any images or videos taken while he/she is in the care of BCP., in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials.

**\*Slumber Party guest hours are 8am-5pm Monday-Friday, Saturday 9am-3pm and Sundays slumber party pets must be picked up at either 11am OR 8pm.**

**\*Grooming Charges:** Pet parents must make it known that they are unhappy with groom prior to paying and leaving premise. REFUNDS will not be issued after this point. Provision of payment states you have agreed to the services rendered. If you are unhappy with your pets groom for whatever reason we want an opportunity to explain why the groomer had to cut/shave a certain way. We want all customers to leave with peace of mind and with the understanding we always do what is best for the pet regardless of vanity- After all its hair and it will grow back :).

**\*Matted Dogs:** If your pet's fur/hair is matted and the length needs to be shorter than what was originally discussed/desired, we will attempt to the contact owner. If the attempt is not answered then the above grooming clause will apply for the comfort of your animal and all charges will apply.

**\*Sundays and Holidays** are charged a FULL DAY RATE regardless of pick-up time.
